Abstract: Authors are required to submit an abstract of maximum 300 words. The abstract must state the objectives, research methodology, analysis and implications of research.

Full Papers: Full papers (in word doc) of upto 5000 words should be electronically submitted. The full paper should include the following: Abstract, max.150 words), Keywords, Introduction, Review of Literature Methodology, Data analysis, Results & Observations if any conclusion and references. The paper should clearly mention the Title, Name of the Author, Name of Institute / Organization, Designation, Track name for which it is being submitted and contact details of the author on its cover page. The manuscript should be formatted as follows:
